

# OFFICIAL RULES

## ALLIANCE RIFLE CLUB 2010 RAFFLES

- **ELIGIBILITY:** Must be 18 years old or older to purchase raffle tickets. To be eligible to win, raffle ticket and monies must be received by September 19, 2010. By entering, the entrant agrees to abide by these official rules and decisions of the Alliance Rifle Club, which are final and binding. Winners of any firearms must possess current Nebraska Firearms Purchase Permit and be legally eligible to obtain a firearm.
- **HOW TO ENTER:** Raffle tickets may be purchased from select Alliance Rifle Club members and retail locations. List of ticket sellers and locations will be listed on the website [www.AllianceRifleClub.com](http://www.AllianceRifleClub.com). Need not be present to win, winners will be directly notified. Tickets are \$50.00 each. The total number of eligible entries will determine odds of winning. Maximum tickets available is set at 100 each month/30 day period starting June 19, 2010 and ending September 19, 2010.
- **WINNER RESPONSIBILITIES:** Prize winners are responsible for any and all federal, state and local taxes, registration, tags, title fees, etc. Entry allows Alliance Rifle Club to post winner's name on their website and any published materials for the purpose of advertising without further compensation unless prohibited by law. By accepting the prize, winner agrees that Sponsor, its affiliates, distributors, advertising and promotional agencies and suppliers and all of their respective officers, directors, employees, representatives and agents shall have no liability for, and shall hold all such parties harmless against damage, loss or injury that may arise in whole or in part, directly or indirectly, from the acceptance, possession, use or misuse of prizes or participation in this RAFFLE.

Miscellaneous: The RAFFLE is subject to all applicable laws in the State of Nebraska and the United States. Raffle held in accordance to State of Nebraska Department of Revenue Lottery and Raffle Act, Title 316, Chapter 35.

Sponsor may prohibit entrants from participating in the RAFFLE and disqualify entries if they attempt to enter the RAFFLE through means not described in the rules, attempt to disrupt the RAFFLE or circumvent the rules, act in an un-sportsmanlike manner or with intent to annoy or harass any other entrant or sponsor(s). All decisions are final. Sponsor makes no warranty, representation or guarantee, express or implied, in fact or in law, relative to the use of the RAFFLE prize including, but not limited to, quality, merchantability or fitness for a particular prize. Entrants agree that any and all claims, disputes and causes of action arising out of or related to the RAFFLE shall be resolved, without resort to any form of class action, exclusively by the appropriate courts in Box Butte County, Nebraska in accordance with the laws of the State of Nebraska, without giving effect to conflict of law rules which would cause the application of the laws of any other jurisdiction.

- DRAWING AND AWARDING OF RAFFLE PRIZE: A random drawing will be made of all eligible and completed entry RAFFLE Tickets received during the Promotion Period (June 2010 to September 19, 2010). List of prizes is divided into 3 sections; one section for each 30 day selling period. June drawing includes prizes 1,6,7; July drawing includes prizes 2,5,8; August drawing includes prizes 3,4,9,10. Grand prize entry does not require additional ticket purchase. All sales from the three monthly raffles will be entered into drawing for Grand Prize. Drawing will take place during the Alliance Rifle Club Gun show on Sunday September 19, 2010 at 2:00 p.m. at the Legion building. If Winner is not present; Winner will be notified by phone or certified mail, return receipt requested, within ten (10) days of the drawing. Winner must claim his/her prize in ninety (90) days.
